
## SECTION - II DEFINITIONS:

#### SECTION - IX - POWER OF THE TRUSTEES:

#### SECTION - XI - AMENDMENTS:

The Trustees from time to time according to the needs of the circumstances, frame, schemes, Rules and Regulations to carryout the objects of the Trust and for Managing the affairs of the Trust and for giving effect to the objects and purposes of the Trust. #### SECTION - XII - MEETINGS:

The Chairman of the Trust Board shall preside over the meetings. The Secretary will convene the meetings.
